

## QuantoPay FIFA World Cup Qatar 2022™ Campaign Terms & Conditions

QuantoPay LTD, a company incorporated in the United Kingdom, having its principal place of business at the Leadenhall Building, 122 Leadenhall Street, City of London, EC3V 4AB, United Kingdom (“**QuantoPay**”), in collaboration with Visa (“**Visa**”) has launched a FIFA World Cup Qatar 2022™ prize draw (“**Prize Draw**”) for all new customers who sign-up to the QuantoPay mobile application (the “**QuantoPay App**”) and refer at least one friend or family member. These terms and conditions (“**Terms**”) apply to any customer who wishes to partake in the Prize Draw, so far as the relevant laws allow it. 4. All winners will be announced and available via the QuantoPay social media pages, and through the QuantoPay Metaverse platform.
5. All winners will also be contacted personally through their registered email address and/or their registered phone number. QuantoPay will in not be responsible for the accuracy of the provided email address and phone number.
6. All customers who have entered the draw will be solely responsible to check their register email address and phone number on a regular basis, as QuantoPay will not be responsible to ensure the receipt of the communication.

7. The Prize Draw will offer a variety of prizes to all eligible customers, including but not limited to, FIFA World Cup Qatar 2022™ tickets, a one-on-one experience with the QuantoPay football legends, and other football-themed merchandise.
